MEMORANDUM OF ASSOCIATION.

1. The name of the society is "The Model School for Infants Society."

2. The Registered Office of the Society will be situated in Kanpur in the State of Uttar Pradesh.

3. The objects of the Society are as follows:-

(i) To impart education on modern methods to children of either sex irrespective of race, caste, creed or religion.

(ii) To teach them etiquettes, manners and disciplines for making them well disciplined responsible and respectful citizens of India.

(iii) To make adequate arrangements for physical uplift and recreation of the children receiving education in the school.

(iv) To employ capable teaching staff and other establishment and to provide, endow or fit out the School with all necessary furniture, sanitation, conveyance and teaching equipment on modern lines for the smooth and efficient running of the school so that it may become a first rate institution for children in Kanpur.

(v) To accept donations and subscriptions from the members of the Society or from the Public in general, to receive

grants in-aid from the Government and local bodies and to raise such funds as are necessary to meet the expenses of the school.

(vi) To acquire by purchase, lease or otherwise building site and to build a school thereon as and when the society secures a suitable plot and the finances permit.

(vii) To manage the school in such a manner and condition as the managing committee may from time to time, prescribe for the aforesaid and such other objects as deemed expedient to promote the cause of education.

(4) Names, addresses and occupations, of the members of the school Managing Committee to whom by the rules of the society the management of its affairs is entrusted.

The Model School for Infants was started by Mr. Fred D. Elias and Mrs. L. Elias after their return in the year 1953 from England where they spent a considerable time and a huge sum of money amounting to Rs.45,000/- for acquiring a good deal of experience in modern methods of Infants education. The plan for opening this school in Kanpur was approved by the Government of India through their High Commissioner in London in the year 1952. The School would be run by "The Model School for Infants Society", Kanpur.

" RULES AND REGULATIONS OF THE SOCIETY. "

1. The word "The Society" where ever it occurs, will denote "The Model School for Infants Society."
2. The objects of the Society will be the same as mentioned in its Memorandum of Association.
3. The Society will consist of the members of the Managing Committee and of an Advisory Board. The Managing Committee will consist of the following :-
 - (a) Life Members- who have borne the expenses amounting Rs.30,000/- in establishing this school in providing two school buses for conveyance of the school children

(b) Such other members as may be added in future to the Managing Committee as and when needed by the majority vote of the existing life-members for the efficient management of the school.

(c) The Manager will exercise all the powers necessary for the smooth and efficient running of the school.

(d) The school will also have an Advisory Board to advise the Managing Committee and make useful suggestions for the efficient management of the school.

(e) Vacancy in the Managing Committee will be filled up by the remaining members of the Managing Committee.

4. President.

Mr. Fred. D. Elias - The Manager of the school will be the permanent President of the Managing Committee and the Principal of the school will act as President in his absence.

5. Meetings.

A General Meeting of the Managing Committee shall be held at least twice viz-in the months of December and May each year on such dates as may be fixed up by the President.

6. Conduct of the business.

A copy of the agenda shall be sent to each member at least one week before the date fixed for the meeting. The resolution will be passed by two third majority votes of the Managing Committee. The President shall have the power of a casting vote in the event of an equality of votes.

7. Appointment.

The appointment of teaching staff will be made by the manager on the recommendation of the Principal of the School on such terms and conditions as may be prescribed.

8. School Budget.

The school budget will be placed before the Managing Committee when it meets during the month of December for their approval.

9. Annual functions:-

An annual Function of the school will be held
